



It's a really simple process to set up your child sponsorship.

Once we receive your completed form, we will confirm your sponsorship and our team in Nepal will allocate a child to you. You will then receive a Welcome Pack, introducing you to the child you are giving a helping hand to. This will include a photograph and background information.

You will receive two updates each calendar year direct from Nepal, keeping you involved with the progress of the child you are sponsoring.

Step 1 – Choose your level of sponsorship.

- If an error is made in the payment of your Direct Debit, by CAF re. The Esther Benjamins Trust or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- If you receive a refund you are not entitled to, you must pay it back when CAF re. The Esther Benjamins Trust asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
